Bankruptcy trustee sells <https://www.oksjonikeskus.ee> in the auction environment of public bailiffs and the Chamber of Bank administrators bankruptcy estate in public electronic auction assets:

The Tulundusühistu Laeva Piim (in liquidation) is a creditor of UP Varud GmbH (in bankruptcy) in civil proceedings No 2-15-17822.

The Tartu Maakohus (District Court, Tartu), in civil case No 2-15-17822, confirmed the allocation proposal of 06.12.2019, which shows the claim of TÜ vessel Piim (in liquidation) against UP Varud OÜ (in bankruptcy) in the amount of EUR 1 549 752.52, which represents 72.709945 per cent of the division.

In addition, TÜ Piim paid a court deposit of EUR 3 500,00 to cover the costs of the bankruptcy proceedings of UP Varud OÜ (in liquidation) and twice granted a loan for the costs of the proceedings, EUR 13 000,00 on 16.02.2017 and EUR 8 000,00 on 10.09.2018, financing the bankruptcy proceedings of UP Varud OÜ (in bankruptcy) in the amount of EUR 24 500,00.

Thus, Ü's total claim on the Piim (bankrupt) vessel against UP Varud OÜ (bankrupt) amounts to EUR 1 574 252.52, of which EUR 1 549 752.52 is a protected claim and EUR 24 500.00 is a claim for legal costs.
