## Notice of publication of a draft environmental permit

Keskkonnaamet publishes this announcement under [Section 47\(2\) of the General Law on the Environment \(KeÜS\)](#).

Keskkonnaamet announces that Skano Furniture Factory Osaühing (registry code: [12503522](#)) (address Rehepapi tn 4, Pärnu linn, Pärnu linn, Pärnu maakond, 80043) the amended draft environmental permit No L.V/329200 has been finalised. Skano furniture factory Osaühing's main activity is the manufacture of wooden furniture (EMTAK 31091 - Manufacture of furniture n.e.c.), which includes surface treatment or finishing with organic solvents as an activity. The production territory has its address in Pärnu County, Pärnu City, Pärnu City, Rehepapi City 4, 80043 (cadastral number 62501:001:0893, target area 55% commercial land 45%, register part 2789605). The emission sources of the Skano furniture factory Osaühing are the flue-gas chimney of the lacillin cab (number on plan or chart S1), the flue-gas chimney chimney chimney (S2), the main-line chimney chimney (S3), the main-line chimney chimney (S4), the flue-gas chimney chimney (S5). The quantity of paints, varnishes and other finishes used shall not exceed 150,5 tonnes per year. The use of chemicals releases up to 11.108 tonnes of VOC per year into ambient air. The main technological equipment used in the collection of privets is a wide range of saws, square furniture and CNC processing centres. The main technological equipment used in the central section is different saws, mills, cages, overlay lines, CNC processing centres. Dust particles from the above operations shall be removed by a closed aspiration system. Wood processing is carried out over a period of approximately 4000 hours per year.

The nearest Natura 2000 site to be protected is the Pärnu River deposit Area (Pärnu) (CLO2000293 in the environmental register), situated approximately 1.6 km south. The nearest protected site for a protected species of category III protected fauna is situated approximately 2 km from the north-east..
