## Notice of declaration of bankruptcy

Harju Maakohus Tallinna kohtumaja publishes this announcement under [Section 33\(1\) of the bankruptcy Act \(PankrS\)](#).

by court order of 12.07.2023 in civil proceedings No 2-23-7491, the debtor, ELDRED OÜ (registry code: [11509356](#)), was declared insolvent at 16:00 on 12.07.2023.

Ly Mürsoo (address OÜ Sentire MK Tallinn, Väike-Ameerika 8-203, 10129, telephone 509 7383, e-mail [ly.myrsoo@mail.ee](mailto:ly.myrsoo@mail.ee)) was appointed as bankruptcy manager.

The first general meeting of creditors will take place at 11:00 on 08.08.2023 at Harju Maakohus Tallinna kohtumaja room 4006.

Creditors are required to notify the trustee in bankruptcy, no later than two months after the date of publication of the notice of bankruptcy in the Official publication Ametlikud Teadaanded, of any claims they have incurred against the debtor before the declaration of bankruptcy, irrespective of the basis on which the claim is incurred and the date on which the claim is due ([§ 93\(1\) of PankrS](#)). Claims not submitted within the prescribed period but recognised shall be satisfied at the final stage ([§ 153\(1\)3 of PankrS](#)). After the declaration of bankruptcy, only the trustee in bankruptcy may accept the performance of an obligation included in the bankruptcy estate and owed to the ([§ 37 of PankrS](#)).

The bankruptcy order is immediately enforceable ([§ 31\(7\) of PankrS](#)). The debtor and the petitioning creditor may file an appeal against the bankruptcy order within 15 days of publication of the notice ([§ 32 of PankrS](#)). The lodging of an appeal against the order does not suspend enforcement of the order ([§ 5\(3\) of PankrS](#)). The enforcement of the bankruptcy order cannot be suspended or postponed, nor can the manner and procedures of enforcement for the bankruptcy order provided by law be changed ([§ 31\(7\) of PankrS](#)). RESOLUTION 1. Grant the application and declare the debtor Eldred OÜ (registry code 11509356) bankrupt on 12 July 2023 at 16:00.2.dismiss Mr Eldred OÜ, the debtor of Kersti Kägi, as interim liquidator .3.Nimeto become the liquidator of the debtor Eldred OÜ Ly Mürsoo.4.Määrata's creditors at the first general meeting on 08 August 2023 at 11.00 in the Tallinn Court of the Harju Maakohus, Club and august at the Tallinn Court of ideal Peace. Lime tn 4 Tallinn .6.Coblige Erik Velleramm (personal identification No: 37208282745), a Member of the board of Eldred OÜ, to submit to the administrator, no later than the date on which the debtor's oath is declared bankrupt, a list of the assets held by Eldred OÜ, including the liabilities .7.trustees are required to notify the trustee, no later than two months after the date of publication of the bankruptcy notice, of any claim against the debtor arising prior to the declaration of bankruptcy, irrespective of the date on which the claim is due and the due. Within the same period, any person who holds the debtor's assets, whatever the basis, shall be obliged to notify the administrator thereof. If the claim is brought after the expiry of that time-limit and the general meeting of creditors does not restore the time-limit for bringing the claim, the claim shall be granted in accordance with the protection provided for in paragraph 102(2) of the PankrS, but, if it is granted, it shall be granted after the approved claims submitted in good time have been satisfied. The enforcement of the obligations owed to the bankrupt debtor may be accepted only after the declaration of bankruptcy. 8.procedural costs and the remuneration of the provisional administrator may be retained by the debtor Eldred OÜ kanda.9.Elder to order the insolvency estate Confere advokatadbüroo OÜ (registry code: 16608577, account No: EE417700771008643484, AS LHV Bank) through which the sworn advocate Kersti is acting, the interim insolvency proceedings order shall immediately be notified to the

parties to the enforcement of the costs incurred by the official Journal of Europe011.10.00..
