Notice of initiating proceedings on an environmental permit

Keskkonnaamet publishes this announcement under [Subsection 2 of § 47 of the General Part of the Environmental Code Act \(KeÜS\)](#).

Keskkonnaamet declares that Marina Minerals OÜ (registry code: [11349875](#)) (address Jalgpalli tn 21, Kesklinna linnaosa, Tallinn, Harju maakond, 11312) an application for an environmental permit for extraction of mineral resources (hereinafter extraction permit) submitted by the Rabaküla sand quarry Mountain allocation (registered in the system of THE Environmental Board EAGLE 20.10.2023 as document No M-126206 -1) has been accepted for processing. The mining section of the sand quarry of Rabaküla is located in Pärnu County, Saarde Parish, in the village of Rabaküla on the state-owned cadastral unit Surju metskond 1. The administrator of the state assets of a cadastral unit owned by the state is the Ministry of Climate Affairs and the authorised authority the State Forest Management Centre. The area of the mining claim is 16.60 ha and the area of the mining claim service plot is 16.60 ha. The proposed mining allocation fully covers the 1 block of active supply stock of sand for construction of Rabaküla sand Mall (register card No 1019 of the mineral resources register) and the 2 block of active supply stock of aggregate sand. According to the application for an extraction permit, as of 30.09.2023 the quantity of active supply of mining reserve construction sand is 76 ash m³ and the extracted stock is 74 ash m³, the quantity of active supply of aggregate sand is 179 ash m³ and the extracted stock is 175 ash m³. The amount of cover is 52 ash m³ incl. soil 52 ash m³. The average annual rate of extraction of mineral resources is applied for 31 thousand m³. The uses of mineral resources include road construction and construction. The direction of the restoration of the extracted land is forest land. An extraction permit shall be applied for for 7 years.
