Notice of termination of bankruptcy proceedings

Viru Maakohus (Jõhvi kohtumaja) publishes this announcement under [Subsection 7 of § 163 of the Bankruptcy Act \(PankrS\)](#).

By court order of 14.12.2023 in civil proceedings No 2-23-6888/20, the debtor Viktoria Nekrassova (national identification 47608062231) (in bankruptcy), bankruptcy proceedings were terminated from due to the abatement following the declaration of bankruptcy as the debtor has no money to make the payments necessary to cover mass liabilities and the costs of bankruptcy proceedings.

Debtor may lodge an appeal on a point of law within 15 days of service of the order ([§ 164\(1\) of PankrS](#), [§ 661\(2\) of TsMS](#)).

The creditor may lodge an appeal on a point of law if he has lodged an objection to the application to close the proceedings in accordance with § 161(2) or § 163(2) of PankrS ([§ 164\(2\) of PankrS](#)).

RESOLUTION 1. Grant the application of Tiia Kalaus 08.11.2023 as a trustee in bankruptcy (trustee). 2. Close the insolvency proceedings of Viktoria Nekrassova (in bankruptcy) due to the abatement following the declaration of bankruptcy due to the debtor's lack of money to pay out the bulk liabilities and the disbursements necessary to cover the costs of the bankruptcy procedures. 3. Confirm the part of the claims recognised by creditors in the bankruptcy proceedings of Viktoria Nekrassova (in bankruptcy) in the amount of EUR 36 196.29, broken down as follows: - TF Bank AB (publ.) Outstanding claims in stages I and III. 4. Finish the bankruptcy proceedings of Viktoria Nekrassova (in bankruptcy). 5. Liberate the trustee Tiia Kalaus Viktoria Nekrassova (in bankruptcy) in bankruptcy proceedings from the duties of trustee and trustee as of the entry into force of the court order approving the final report. 6. Determine the remuneration of the trustee in bankruptcy Tiia Kalaus in the amount of EUR 1 217 (one thousand two hundred and seventeen euros 00 cents, including VAT). 7. Grant Viktoria Nekrassova procedural assistance for the payment of the remuneration of the trustee in bankruptcy (trustee) and reimburse from state funds 720 euros (seven hundred and twenty euros, including VAT) which are not disbursed to state revenue (pursuant to subsection 183(2) of the TsMS). That amount is to be credited to OÜ Civilex account No. EE312200221055387366 AS Swedbank. 8. Leave the administrator's remuneration of EUR 497 (four hundred and ninety-seven euros, including VAT) to Viktoria Nekrassova and order Viktoria Nekrassova to pay that amount to OÜ Civilex account No. EE312200221055387366 AS Swedbank from the insolvency estate of Viktoria Nekrassova at the request of Tiia Kalaus. 9. The waiver procedure for Viktoria Nekrassova will continue. The debtor is

required to comply with the rules laid down in § 47 of the FiMS in the bail-in procedure .10.Name Viktoria Nekrassova as Trustee Svetlana Sorokina in the bail-out procedure (personal identification code 48006242737, NGO Vabane debt, Rotermann tn 6, Tallinn, e-mail: vabane.volgadest@gmail.com; tel. 556 78698). The trustee shall submit an annual report to the court on the proceedings for the release of the debtor from his or her obligations. The deadline for submitting the first report is 16.05.2024. 11. Publish a notice of termination of bankruptcy proceedings in the publication Official Announcements. 12. Send the order to the participants in the proceeding for information and after entry into force to the State support services Centre for execution of the payment specified in clause 7).
