Notice of approving the list of creditors

Harju Maakohus Tallinna kohtumaja publishes this announcement under [Subsection 8 of § 100³ of the Bankruptcy Act \(PankrS\)](#).

By order of 26.02.2024 in civil proceedings No 2-23-1995, the list of creditors submitted by the debtor's, Qsys Eesti OÜ (registry code: [11467600](#)) (in bankruptcy), trustee, was confirmed.

An appeal against a ruling by which a court has approved a list of creditors may be filed by the trustee, the debtor who filed an objection, the creditor who filed or received an objection and the creditor whose request for restoring the claim was not satisfied may lodge an appeal within 15 days of service of the order ([paragraph 100³ \(7\) of the](#) PankrS, paragraph 661(2) of the TsMS).

1. Grant the following requests: 1.1. Objection of the liquidator of qsys Eesti OÜ to the claim of Minigrupp OÜ in the amount of 1170 euros and the claim for late payment in the amount of 94.19 euros. 1.2. Objection of the liquidator of qsys Eesti OÜ to Oleksandr Vorobei's claim of EUR 5044,18. 1.3. Objection of the liquidator of qsys Eesti OÜ to Kaido Koosner's claim in respect of EUR 730.96. 1.4. Objection of the liquidator of qsys Eesti OÜ to Sergei Zacetapilini's claim of EUR 5658.13. 1.5. Objection of the liquidator of qsys Eesti OÜ to the claim of Hekler industrial HR OÜ in the amount of 0.60 euros. 1.6. Objection of the liquidator of qsys Eesti OÜ to Tehnoaudit OÜ's claim for late payment interest in the amount of 83.81 euros. 1.7 Objection of the trustee in bankruptcy of Qsys Eesti OÜ, creditor CitySecurity OÜ and debtor to Nomse OÜ and olev Nurme's claim of EUR 20 210.70 and fine for late payment of EUR 53 758.62 because it has expired .1.8 Nomse OÜ and Oleg Nurme's claim for non-material damage of 900,000 must be considered not to have been filed. 1.9. The claim for loss of profit of nomse OÜ in the amount of EUR 256 836.51 must be considered not to have been submitted. 1.10 Objection of the liquidator, debtor and creditor of Qsys Eesti OÜ City Security OÜ to DAS Ehitus OÜ's claim of 36,187.14 euros and fine for late payment of 395.58 euros. 1.11. Objection of the liquidator, debtor and creditor of qsys Eesti OÜ City Security OÜ 1Partner Ehitus OÜ. 1.12. Application by the Compensa Vienna Insurance Group for restitutio in integrum. 2. Dismiss the following requests: 2.1.Võlnik's objection to Kaido Koosner's remuneration of EUR 2 800; 2.2. The debtor's objection to alter Baltics OÜ's claim for late payment of EUR 1793.87. 2.3. Objection of the liquidator of qsys Eesti OÜ to THE claim for late payment of 87.97 euros t.2.4 of the TSI Grupp OÜ. The debtor's objection to the claim of Luminor Liising AS in the amount of EUR 415.38 .2.5. An application of the tax and Customs Board for restoration of the term for filing a claim. 3. Confirm the list of creditors submitted in the bankruptcy proceedings of Qsys Eesti OÜ (in bankruptcy).
