Notice of initiating proceedings on an environmental permit

Keskkonnaamet publishes this announcement under [Subsection 2 of § 47 of the General Part of the Environmental Code Act \(KeÜS\)](#).

Keskkonnaamet declares that OÜ ORGITA DOLOMIIDITOOTED (registry code: [10713994](#)) (address Kulliaasa, Sulu küla, Märjamaa vald, Rapla maakond, 78253) the application for an environmental permit for Orgita's IV dolostone quarry submitted on 05.06.2023 (the corrected application was submitted on 30.11.2023 and duly supplemented by a letter from company 07.02.2024; the documents are registered in the EAGLE on 30.11.2023 with numbers DM-125020-6 and 09.02.2024 with numbers DM-125020-12 respectively) has been accepted for processing.

The company OÜ ORGITA DOLOMIIDITOOTED is applying for an environmental permit to mine high-stamp construction dolostone, finishing dolostone and filling dolostone from the mining allocation, wanting to use the material to produce finishing stones, finishing tiles, natural stones, wall and block stones. Material to be extracted from which finishing stones, tiles or natural stone cannot be produced is used for the production of rubble.

The requested Orgita IV dolostone quarry is located in the village of Orgita in Märjamaa Parish, Rapla County, for state-owned cadastral units Paaekarjääi (identifier: 50402:001:0940, administrator of state assets by the Ministry of Regional Affairs and Agriculture and authorised authority Maa-amet) and Märjamaa Forest 23 (Identifier: 50402:001:0181, State assets managed by the Ministry of Climate Affairs and State Forest Management Centre as authorised authority). The area of the mining claim is 8.73 ha and the area of the mining claim service area is 10.34 ha.

The mineral resources to be extracted are high-stamp construction dolostone (capacity 95.40 ash m³), finishing dolostone (capacity 16.80 ash m³) and filling dolostone (capacity 428.70 ash m³). An environmental permit for orgita's IV dolostone quarry is applied for 30 years with an average annual mining capacity of 19 ash m³. The land extracted shall be restored to land (forest land) and to the protected species Triturus cristatus (cultivated water) in category II.
