Bankruptcy trustee sells <https://www.oksjonikeskus.ee> in the auction environment of the Chamber of bailiffs and bankruptcy administrators bankruptcy estate in public electronic auction assets: Jevgenija Savostkina (deceased on 02.06.2009, personal identification code 42701010346), a notional share of 2/12 belonging to Olesja Landsberg, on the commonality of the estate.

According to the response of the notary who conducted the succession proceedings, the estate of Yevgenija Savostkina (bequeather) included part of the buildings in joint ownership of the bequeather and his or her spouse, located in Kasepää hamlet, Peipsiääre rural municipality, Tartu county (as a movable).

According to the reply of the national Archives, on the basis of the purchase-sale agreement of 05.01.1970. in the archives file, the ownership of the house was acquired by Yevgenia Jakovi t Savostkina and Zakhar Nikiti p Savostkin in the former village Council of Peipsiääre, the village of Kasepää, the area of Kolhoosi Zarja in equal proportions (both ½ parts).

The state of the construction work is not known to the trustee in bankruptcy..

The bid step for auctions be 50 EUR (s).

Bids can only be made in the auction environment according to the conditions indicated in the auction environment.

The winner of an electronic auction pay the purchase price on the working day following the day on which the auction ends, as pursuant to [§93\(3\) of TMS](#). If the purchase price exceeds EUR 12 700, the auction winner must pay one tenth of the purchase price immediately after the end of the auction, the remaining price having to be paid within 15 days.
