## Notice of termination of bankruptcy proceedings

Harju Maakohus Tallinna kohtumaja publishes this announcement under [Subsection 7 of § 163 of the Bankruptcy Act \(PankrS\)](#).

By court order of 14.08.2024 in civil proceedings No 2-23-5660/17, the debtor MERILYN SAAR (national identification 49204250018) (in bankruptcy), bankruptcy proceedings were terminated from due to the abatement after the bankruptcy was declared.

Debtor may lodge an appeal on a point of law within 15 days of service of the order ([§ 164\(1\) of PankrS](#), [§ 661\(2\) of TsMS](#)).
