Pärnu Maakohus (Rapla kohtumaja) publishes this announcement under [Subsection 4 of § 29 of the Bankruptcy Act \(PankrS\)](#).

by order of 17.12.2024 in civil proceedings No 2-23-3676/37, the procedure for the declaration of insolvency of the debtor, KERLI TÄHT (national identification 49607252028), , was terminated by abatement by ruling.

The debtor and the applicant may lodge an appeal within 15 days of service of the order ([§ 29\(6\) of PankrS](#) ; [§ 661\(2\) of TsMS](#)). Where an appeal against a decree is brought by a creditor who has not filed an application for insolvency, the time-limit for lodging an appeal starts to run from the date of publication of this announcement ([§ 29\(7\) of PankrS](#)). 17.12.2024 Resolution 1 OF the order of Pärnu County Court. Terminate the bankruptcy proceedings of Kerli Tähe (Star, bankrupt, personal identification code 49607252028) following the declaration of bankruptcy due to abatement, as the bankruptcy estate does not have sufficient funds to make the necessary disbursements to cover the costs of the bankruptcy procedure. 2. Kerli Star (bankrupt) in bankruptcy proceedings, creditors have been forfeited in respect of the recognised receivable: 2.1. A total of EUR 10 591.65 in respect of claims in the order II (paragraph 153(1) (2) of the PankrS) is as follows: the amount of the creditor's money foregone is 1. ESTO AS (14180709) 839,242. Publish a notice of termination of bankruptcy proceedings due to the abatement of bankruptcy proceedings in the publication Ametlikud Teadaanded. 4. Liberate the trustee in bankruptcy in the bankruptcy proceedings of Martin Pärn Kerli Star from his duties after the completion of the bankruptcy proceedings. 5. Assign a salary of EUR 800 to Martin Pärna, the trustee in bankruptcy of Kerli Star, plus VAT of EUR 176, i.e. a total of EUR 976. 8. Continue the decommitment procedure initiated against Kerli Tähe on 19.04.2023. The debtor is required to comply with the rules set out in § 47 of the FiMS in the decommitment procedure. 9. Liberate the trustee of the trustee Martin Pärn Kerli and appoint Evelyn Eichhorst as the trustee of the star of Kerli Tähe in the decommitment procedure (personal identification code 47501254214, location Tallinna mnt 19-7, Pärnu city, telephone +372 53306936, e-mail evelyn.eichhorst.parnu@gmail.com). 10. The trustee is required to submit an annual report on the performance of the obligations of the debtor to Pärnu County Court (electronically via a public e-file to the pmkrapla.menetlus@kohus.ee or e-mail address <https://www.e-toimik.ee/> or on paper to the postal address Sauna tn 5, Rapla) by 19 April, the first report to be submitted on 19.04.2025. 11. Deliver the court ruling to the debtor, trustee in bankruptcy, creditors, new trustee and after entry into force to the State support services Centre for the execution of clause 6 of the operative part of the court ruling. Upon termination of the bankruptcy proceedings, the debtor may file an appeal against the ruling (subsection 164(1) of the PankrS). A debtor, creditors and trustee in bankruptcy may file an appeal against a ruling concerning compensation for the remuneration of a trustee in bankruptcy (subsection 150 (5) of the PankrS). An applicant for or recipient of procedural assistance or the Republic of Estonia may file an appeal against a ruling on granting procedural assistance through the Ministry of Finance or an agency within the area of government of the Ministry of Finance designated by the minister responsible for the area (subsection 191(1) of the TsMS). An appeal against a ruling shall be filed with the Tallinn circuit Court through Pärnu County Court within 15 days as of service of the ruling. A state fee shall be paid upon filing of an appeal against a ruling. If a notice or

procedural document is to be served by public service, the document shall be deemed to have been served five days after the publication in Official Announcements (subsection 6 (1) of the PankrS).
