## **Notice of termination of bankruptcy proceedings**

Harju Maakohus Tallinna kohtumaja publishes this announcement under [Subsection 7 of § 163 of the Bankruptcy Act \(PankrS\)](#).

By court order of 23.01.2025 in civil proceedings No 2-21-19192/44, the debtor KRISTJAN SIIMANN (national identification 39212306836) (in bankruptcy), bankruptcy proceedings were terminated from abatement after the declaration of bankruptcy as the debtor has no money to make the payments necessary to cover mass liabilities and the costs of bankruptcy proceedings.

Debtor may lodge an appeal on a point of law within 15 days of service of the order ([§ 164\(1\) of PankrS](#), [§ 661\(2\) of TsMS](#)).

The creditor may lodge an appeal on a point of law if he has lodged an objection to the application to close the proceedings in accordance with § 161(2) or § 163(2) of PankrS ([§ 164\(2\) of PankrS](#)).
