Notice of compulsory winding-up

Under paragraph 60(2) of the commercial Code, paragraph 36.1 (2) of the Law on non-profit-making associations and paragraph 34.1 (2) of the Law on foundations, the Registrar of the Maakohus de Pärnu informs the registrar that the following undertakings, non-profit-making associations and foundations have not submitted to it, within the period prescribed by law or by the registrar, an annual report or a valid reason precluding the submission of an annual report. Within 6 months of the publication of this notice, creditors of a company, non-profit-making association or foundation may notify the registrar of their claims against the association or body and request that winding-up proceedings be instituted against the association or body. If, within 6 months of the publication of this notice, an association or body has not submitted an annual report to the registrar or provided reasons for not submitting an annual report, and the creditors of the association or body have not requested the liquidation of the association or body, the registrar may be removed from the register of the association or body. If, within 6 months of the publication of this notice, a creditor or an association or body of an association or body submits an application for liquidation, the registrar shall decide on the compulsory winding-up of the association or body in
