The Environment Agency States that the Krüüdneri Karjäär OÜ (registry code: 10698390) (address at Näituse tn 21, 50409 Tartu) 29.12.2016. a request for a mining permit for the Krüüdner sandy deposit of local significance (registry card 0320) Krütner's sandy quarry No 12-2/16/15182-1 was accepted. Authorisation No L.MK/324802 has been granted for the extraction of building sand and gravel on the Krydner sandpasture at the Krydner site. The mountain allocation of the crystal sandy quarry is located in the Krüüdner Village, Põlva County, League garden (Cadastral Identifier No 85601:002:0001; surface area 5,14 ha), Järve (Cadastral Identifier No 85601:002:0101; surface area 0,35 ha).
