The Environment Agency States that the application for authorisation to PROSPECT for the Tammistu exploration room submitted by as TREV-2 Group (registry code: 10047362) (address Pärnu mnt 463, 10916 Tallinn) 07.02.2017 (registered under document Management system 09.02.2017 No 12-1/17/2331 of the Environment Agency) has been accepted.

The geological survey is requested in Pärnu, County Varbla, in the village of dog, in the State-owned cadastral division Varbla, district 63 (cadastral mark 86302:003:0056), which is managed by the Ministry of the Environment and an authorised authority by the State Riigimetsa Majandamise Keskus.
