The Environment Agency States that the APPLICATION for authorisation to PROSPECT for a gambler X research room submitted by as TREV-2 Group (registry code: 10047362) (address Harju County, Tallinn, Nõmme district, Pärnu mnt 463, 10916) on 20.03.2017 (registered under document management system of the Environment Agency No 20.03.2017 No 12-1/17/3480-6) has been accepted.

The geological survey is requested in the village of Männite and Tammemäe in Harju, County Freistaat Sachu, for State-owned cadastral districts Viims district 13 (cadastral title 71801:001:1259) and Viimsi district 242 (cadastral title 71801:001:1406), for which the State property manager is the Ministry of the Environment and the authorised authority is the State Forest Riigimetsa Majandamise Keskus. The size of the service area of the applicant survey room shall be 64,65 ha.
