The Environment Agency reports that the EXCAVATOR of OÜ AAB (registry code: <u>11202273</u>) (address: Kungla tn 56c, Valga City, Valga County, 68205) submitted an application for authorisation to exploit the mineral resources of the mountain deposit of the Säre sand quarry (registered in the Environment Agency's document management system 21.04.2017 No 12-2/17/5140).

The mountain allocation of the shirt sandy quarry is located in the Säre sandpastry deposit (registry card No 0944) in the municipality of Antsla, in the municipality of Võru, in the village of Säre, on the land registry division Kunnamäe (cadastral identification No 14302:002:0411).
