The Environment Agency reports that the OSAÜHING KAPASTU (registry code: <u>10261888</u>) (address: Kapasto alajaam, village Nõmba, Municipality of Pühalepa, County Hiiu, 92363) submitted an application for authorisation to exploit mineral resources.

THE OSAÜHING KAPASTU applies for authorisation to exploit the mountain deposit of the Määvli sandy pasture in the Määvli-Kapasto sandy pasture.
