The Environment Agency States that the application for authorisation to prospect for the exploration room in Jägala IV submitted by the OÜ of Mineral resources (registry code: <u>14212964</u>) (address: Kuusiku tee 18-13, Loo alevik, Municipality of Jõelähtme, County Harju, 74201) on 18.09.2017 (registered under document management system 18.09.2017 No 12-1/17/10631 of the Environment Agency) has been accepted.
