According to that authorisation for prospecting, Kalda Kivi OÜ is authorised to carry out a geological survey in the Noonu prospecting room in the region of West Viru, in the municipality of Haljala (formerly the municipality of Vihula), in the village of Noonu, in the land of Kalda (cadastral mark 88702:002:0102).
