The Environment Agency States that the application for authorisation for the general geological exploration of the Nepste IV exploration room submitted by OÜ of Mineral resources (registry code: 14212964) (address: Kuusiku tee 18-13, Loo alevik, Municipality of Jõelähtme, 74201 Harju County) on 17.01.2018 (registered under document management system No 12-2/18/880 of the Environment Agency) has been accepted.

Authorisation to carry out general geological exploration is sought in the municipality of Häädemeeste, Pärnu, on a state-owned property in the village of Nepste, Liksaare district 2 (cadastral title 21302:001:0094), the management of which is the Ministry of the Environment and the authorised authority of the State Riigimetsa Majandamise Keskus. The area covered by the requested survey room is 153.57 ha. The purpose of the research is to identify a potential source of sufficient quality for the construction and filling sands. The exploration project envisages the construction of up to 50 exploration voids and up to 50 wells with a depth of up to 15 m; other planned ad hoc work: laboratory tests, topographical work, water level measurement and, where appropriate, other experimental work.
