## Notification of the publication of a draft air pollution permit

The Environment Agency publishes a notice under <u>paragraph 47(2) of the General Law on the</u> Environment (KeÜS) (since 01.01.2017, formerly PARAGRAPH 78(1)).

The Environment Agency reports the completion of draft Air pollution permit No L.V/330907 for OÜ Kõo Agro (registry code: 10070214) (address: Ain, Municipality of Kyo, Municipality of North Sakala, 70501 Viljandi County) and draft air pollution permit decision, decision not to initiate an environmental impact assessment and draft preliminary assessment. Air pollution permit is requested for an emission source at the border between the Araka site (registration number 2016939, cadastral mark 35701:001:1160) and the Mangelu site (registration number 1303139, cadastral mark 35701:002:1511) in the village of Koksvere, in the municipality of Viljandi, Northern Sakala. The air pollution permit is requested for an unlimited period. The application for an air pollution permit was accompanied by the information referred to in paragraph 61(1) of the Law on environmental impact assessment and the environmental management system (KeHJS).

The site of the installation is located at the border between the Araka and Mangelu sites. Both properties are for 100% earning land. The land is predominantly enclosed with land used for arable land, as well as residential, transport and land used for public purposes. The nearest dwelling is situated approximately 400 metres from the border of the production area. The installation is not situated in a conservation or conservation area, in a Natura 2000 bird area or in a nature area. Protected natural sites do not exist in the territory.

The main activity of the holding is the cultivation of fodder crops, grass crops and other annual crops (EMTAK code 01199). It applies for an air pollution permit for the establishment of a lagoon-type slurry storage facility for cattle farms in the region. Lagoon is designed as a separate object.

The Environment Agency examined the compliance of the application for an air pollution permit and THE LHK project with the requirements of Regulation No 74 of the Minister for the Environment of 27.12.2016, entitled "specific requirements for an application for an air pollution permit and a permitted emissions project, application for an authorisation and permit forms", and whether the application for an air pollution permit had been accompanied by all the information referred to in paragraph 61(1) of the Law on environmental impact assessment and the environmental management system (also "the KeHJS"). The application for a pollution permit submitted and the information referred to in paragraph 61(1) of the KeHJS".
