The Environment Agency States that the application for authorisation to prospect for the exploration room for the Mõishalla IV (registered under document management system of the Environment Agency 13.09.2018 under document number 12-2/18/15014) submitted by the OÜ of Mineral resources (registry code: 14212964) (address: Kuusiku tee 18-13, Loo alevik, Jõelähtme vald, Harju County, 74201) has been accepted.
