THE AKTSIASELTS KIVILUKS is applying for THE merging and extension by 15 years of mining permits HARM-111 and harm-123 for the Mediterranean deposit Vahelaane II and IV GRAVEL quarries.

The gravel quarries of Area II and Area IV are located in the privately owned cadastral parcels Kiviraider (cadastral identification 14002:003:0142) and the Baltic gaming parcel (cadastral identification 14002:003:0397) in the Harju County of Anija. The area of the mountain allocation applied for is 11.50 ha and that of the service area of the mountain allocation is 11.97 ha.
