### **Notification of the publication of a draft integrated permit**

The Environment Agency publishes a notice pursuant to [paragraph 34\(1\) of the Industrial emissions Act \(THS\)](#).

The Environment Agency reports that the Osaühing MARKILO (registry code: [10317169](#)) (address Ööbiku tn 4, Rakvere, 44315 Western Viru County) has prepared draft integrated permit and amended draft permit No L.KKL.JÕ-152977 for the Kureoja FARM. The coffee farmer farm is located in Jõgeva County, Härjanurme village, on the plots of the Kureoja farm (cadastral number: 61101:001:0119) and Kureojamesa (cadastral number: 61101:001:0118).

THE OSAÜHING MARKILO is seeking to extend the Kureoja farm to a production capacity of up to 940 seats for pigs for fattening. To that end, the southern part of the pig area has been reconstructed and the northern part of the pig is also planned, in which all the pigs are reared on the full slatted floor and only liquid manure is produced. The pig complex has in the past been the subject of a new repository for liquid manure with a basic circle plan and, in addition, a secondary repository for liquid manure is planned.

An environmental impact assessment has been carried out on the reconstruction of the cocktail's farm and on the increase in production capacity and a report entitled "environmental impact assessment report on the extension of the MARKILO Kureoja pig farm", approved by the Environment Agency on 19.02.2018 (registered in the Environment Agency's document register under document number <https://dhs-ADR-kea.envir.ee/> No 6-3/17/498-25).

Proposals and objections to the draft (s) may be submitted to the Environment Agency orally or in writing to Paala tee 4, 71014 Iljandi or [info@keskkonnaamet.ee](mailto:info@keskkonnaamet.ee) until a decision is taken to grant or refuse integrated environmental permit, but within a period of at least three weeks from the date of publication of the notice in the Official Journal Ametlikud Teadaanded.

The Environment Agency shall propose to hear the case without holding a public hearing.
