The Environment Agency States that the request FOR amendment OF the environmental permit for the extraction of mineral resources submitted by as TREV-2 Group (registry code: <u>10047362</u>) (address Harju County, Tallinn, Nõmme district, Pärnu mnt 463, 10916) has been accepted.

The request for modification of the mining permit for the gravel quarry of the sail is made at the Purila gravel deposit (registry card No 0826) of the village of Röa, Rapla, as TREV-2 Group, on the private cadastral unit Kutseri (cadastral mark 66901:001:0776).

The area of the existing mountain allocation for the gravel quarry in Purila is 5.18 ha and the area of the service area for the mountain allocation is 6.83 ha (according to the adjusted graphical annexes, the area of the mountain allocation is 5.17 ha and the area of the service area for the mountain allocation is 6.81 ha). The minerals to be extracted are, as of 31.03.2018, the building gravel (an active consumable reserve of 56,8 thousand m3 and an excavable reserve of 42,8 thousand m3), building sand (an active consumable reserve of 7,4 thousand m3 and an excavated reserve of 6,4 thousand m3) and the aggregates sand (an active consumable reserve of 4,3 thousand m3 and an excavable reserve of 2,3 thousand m3) and the fields of use are construction and road construction.
