The application for a geological exploration licence shall be made on land owned by Lepalinnu (identifier 71102:001:0135) and Allar Pinnar, a Member of the board of directors of Grenor Trade, on land owned by the applicant in Lodja village Saarland (ID 71001:001:0254). The area covered by the requested survey room is 4.38 ha.
