Keskkonnaamet publishes this announcement under [Section 47\(2\) of the General Law on the Environment \(KeÜS\)](#).

Keskkonnaamet declares that EMG Karjäärid OÜ (registry code: [14273374](#)) (address Vana-Narva mnt 11b, Kiiu alevik, Kuusalu vald, 74604 Harju maakond) the application for an environmental permit for the God IX sandy quarry has been accepted on application.

The environmental permit is applied for in the village Tammejärvi, Harju County, Freistaat Sachu, for the cadastral district Viimsi 10 (cadastral title: 71801:001:2151), which is owned by the Ministry of the Environment and an authorised authority by the State Riigimetsa Majandamise Keskus.

The area IX by the sandy quarry applied for is 16.00 ha and the area covered by the mountain quarry is 18.58 ha. The extracted minerals are, according to the application, building sand (2 672 thousand m³ active consumables and 1 868 thousand m³ extracted reserves) and aggregates sand (632 thousand m³ active consumables and 619 thousand m³ extracted reserves). The intended use of the mineral resource is construction materials, construction and road construction. The average annual extraction rate applied for is 170 thousand m³. An environmental permit is requested for a period of 15 years.
