## Notice of initiation of proceedings for an environmental permit'

Keskkonnaamet publishes this announcement under [Section 47\(2\) of the General Law on the Environment \(KeÜS\)](#).

Keskkonnaamet declares that AS TREV-2 Grupp (registry code: [10047362](#)) (address Pärnu mnt 463, Tallinn 10916) the application by the applicant for amendment of environmental permit [L.MK/319043](#) for the extraction of the sandy mineral of the Helm-Aakre IV quarry has been accepted. The sand quarry of Helm-Aakre IV (an area of the mountain allocation of 2,39 ha, an area of the service area of 2,39 ha) is located in the catchment area "Oona-Nurmi 3" (identifier 60801:001:0304) in the municipality of Elva, Tartu, and belongs to the applicant. The area applied for is the Helm-Aakre sandy deposit (registry card 0518). AS TREV-2 Group applies for a 15-year IV of environmental permit L.MK/319043 for the extraction of sandy quarries OF Helm-Aakre IV in order to exploit the existing sand stock until the end of the quarry and then to clean up the quarry. Mining permit [L.MK/319043](#) is valid until 01.07.2021. The sand quarry of Helm-Aakre IV has an area of mountain allocation of 2,39 ha, an area of service of 2,39 ha. According to the request for amendment of the mining permit, the active consumption of mining reserves on the building sand (14 blocks) is 36.268 thousand m<sup>3</sup>, and on the aggregate sand (15 blocks) is 12.894 thousand m<sup>3</sup>. The excavated reserves in the construction sand 27,268 thousand m<sup>3</sup>, in the aggregate sand 9,894 thousand m<sup>3</sup>. The average annual extraction rate is requested to be 13.7 thousand m<sup>3</sup> (the quantity of mineral resources is reported as at 31.03.2020). Amount of overburden (including earth) 5,048 thousand m<sup>3</sup>. Mineral uses include construction and road construction. Land used for land consolidation (wooded land) is the direction of the reclamation. The period of validity of the permit applied for is 15 years (up to 01.07.2036).
