Notice of initiation of proceedings for an environmental permit'

Keskkonnaamet publishes this announcement under [Section 47\(2\) of the General Law on the Environment \(KeÜS\)](#).

Keskkonnaamet declares that EMG Karjäärid OÜ (registry code: [14273374](#)) (address Harju maakond, Kuusalu vald, Kiiu alevik, Vana-Narva mnt 11b, 74604) the application for an environmental permit for the extraction of mineral resources submitted by the applicant has been granted in respect of the deposit of the Neruti sandy pasture.

The sand quarry of Neeruti (an area served by a mountain allocation of 7,77 ha of mountain allocation of 6,34 ha) is located in the municipality of Otepää, Valga, in the municipality of Neerut, in the cadastral district of Neeruti, in the cadastral district of Neeruti (cadastral identification: 58202:003:0010) and the cadastral area (cadastral identification: 58202:003:0003). These properties are State-owned, the quarry of the cadastral unit Neeruti falls within the remit of the Road Administration and the cadastral division within the remit of the land administration of the Land of Kruusland. The area applied for is located on block 10 of the active consumption of the building sand of the Neerut gravel deposit and block 11 of the filling sand (registry card 0381).

According to the request for an environmental permit for the extraction of mineral resources, the active consumption of mining reserves in the building sand (10 blocks) is 261 thousand m³, and in the aggregate sand (11 blocks) is 46 thousand m³. Excavated reserves at 243 thousand m³ in the building sand, 40 thousand m³ in the aggregate sand. The average annual extraction rate is requested to be 30 thousand m³ (the quantity of mineral resources is presented as at 01.02.2020). Quantity of overburden 23 thousand m³, including quantity of soil 13 thousand m³. Mineral uses include construction and road construction. The direction of the reclamation shall be arable land (wooded land) and surface water. The period of validity of the authorisation applied for shall be 15 years.
