Keskkonnaamet publishes this announcement under [Section 16\(2\)\(1\) of the environmental impact assessment and Management system Act \(KeHJS\)](#).

Environmental Agency announces the publication of the environmental impact assessment (EIA) programme of the Project for reclamation of Lake Kernu.

The EIA was initiated by letter No 6-3/21/6267-2 of the Environment Agency 12.04.2021.

The objective of the planned operation is the restoration of the Kernu barrage (dredging of a body of water with a total capacity of 130 000 m³) and, at the same time as the extraction of sludge, it is planned to construct a widening of the surface of the road dam. The construction of a tip extension is necessary in order to reduce the filtration through the surface and to make the movement of pedestrians safer. The Lake Kernu is located in an Kohatu village in the municipality of Saue on the cadastral unit Kernu Lake (cadastral identification: 29701:005:0425).
