The auction winner cannot set off the purchase price against his claims against AS Jumax (in bankruptcy). The asset is sold in its condition at the time of delivery (as is) and the liquidator does not give any assurances or guarantees in respect of the asset and is not liable for any defects in the asset (including the complete exclusion of the seller's liability), regardless of whether those defects have been disclosed to the bidders.

The auctioneer shall be required, within 5 days of the transfer of ownership, to submit to the Office of the Town and country Register the information necessary for the purpose of transforming the ownership of the motor vehicle into a register of vehicles.
