The auction winner cannot set off the purchase price against his claims against AS Jumax (in bankruptcy). The asset is sold in its condition at the time of transfer (as is) and the liquidator does not give any assurances or guarantees in respect of the asset and is not liable for any defects in the asset (including the complete exclusion of liability of the seller), irrespective of whether whether the relevant deficiencies have been disclosed to the participants in the auction.
